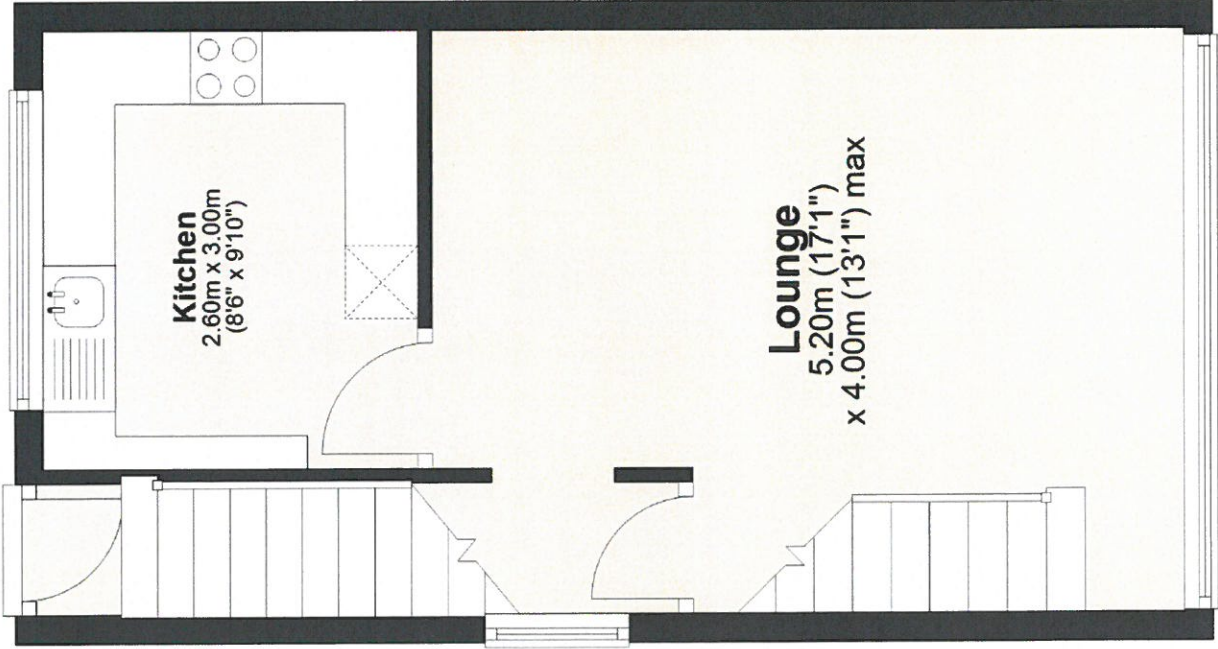

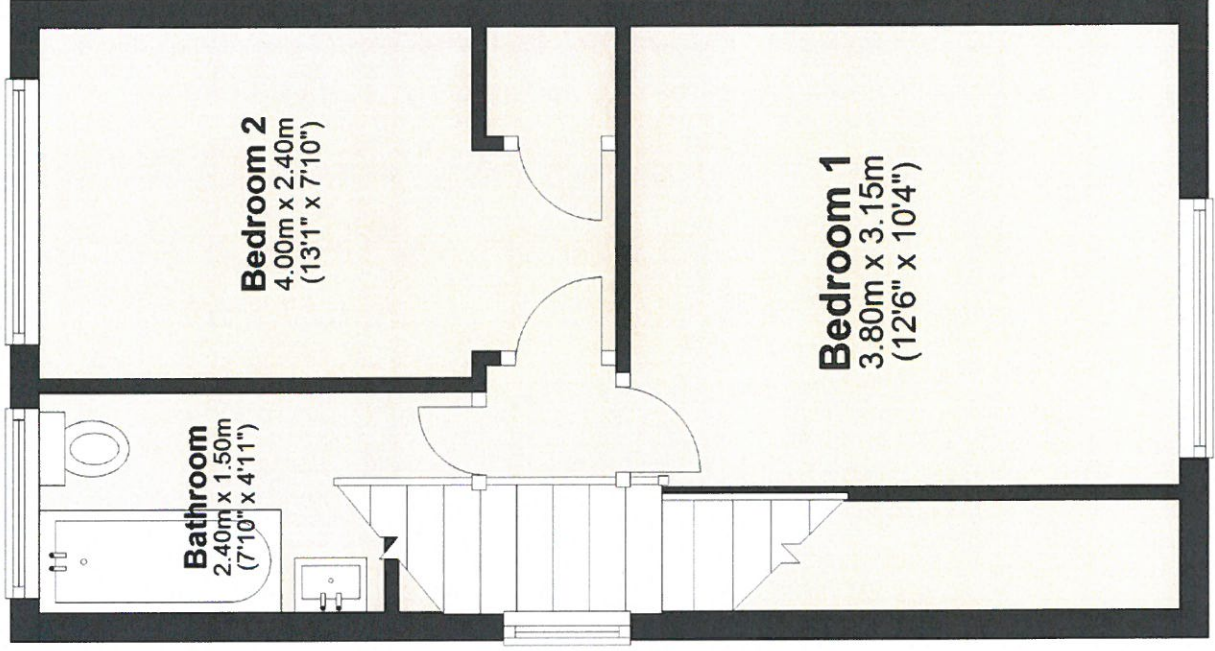

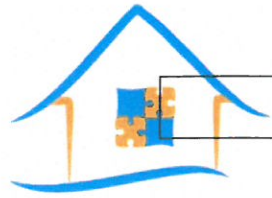


Second Floor
