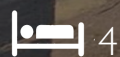

If you are looking for a great family home with flexible accommodation and a number of extras, look no further! Offering 4 receptions, extended kitchen, utility and WC whilst upstairs 4 double bedrooms, family bathroom and en-suite shower. Whilst outside you will find a large garden with open aspect to the side, detached garden room / home office and ample parking.

Approach

For those that don't know, Raeburn Avenue is a lovely tree-lined street with predominately traditional 1930s semis on either side. This particular property has the benefit of sitting on the corner plot and offers a 2-story side extension.

You will find ample off-road parking at the front with access to the side and a central entrance.

From the hallway you have access to principle rooms and stairs to the first floor. Starting on the right-hand side you will find the sitting room / snug which forms part of the extension offering well-proportioned accommodation and benefitting from a built-in media wall.

On the left of the hall you have the other well-proportioned reception room with bay window to the front allowing natural light pour in. Making your way to the rear you will find the dining room off the kitchen which connects to the large conservatory at the rear with French doors opening onto the garden. Connecting door back into the kitchen.

Extended Kitchen

The kitchen extends to the side and provides a wide range of white wall and base units with contrasting worktop, space for appliances and integrated oven and hob with aspect to the rear. Connecting door leads into the utility room with plumbing for white goods, wall-mounted boiler and connecting door to the downstairs WC.





Making your way upstairs

The landing splits to the left and right providing access to principle rooms.

Bedrooms

Positioned at the front of the property you will find the master suite offering a well proportioned double bedroom with fitted wardrobes and en-suite shower room off. You are spoilt for choice, 3 further double bedrooms with two positioned at the rear and one to the front.



Family Bathroom

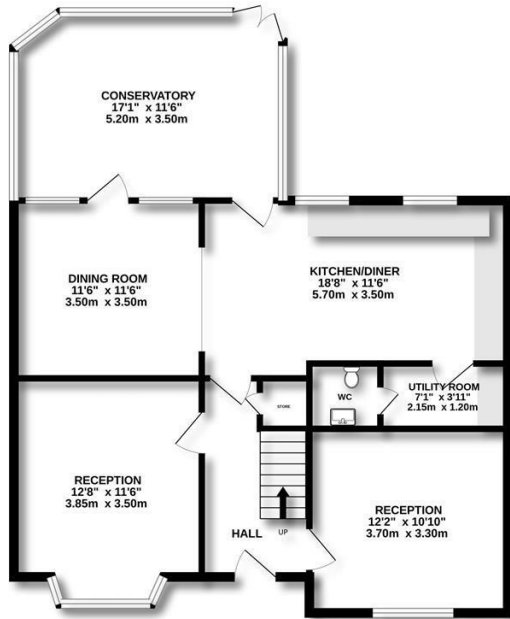
A modern white suite incorporating low level flush toilet, wash hand basin and panelled bath with shower above, tiled walls and towel rail and window to the rear.

Garden

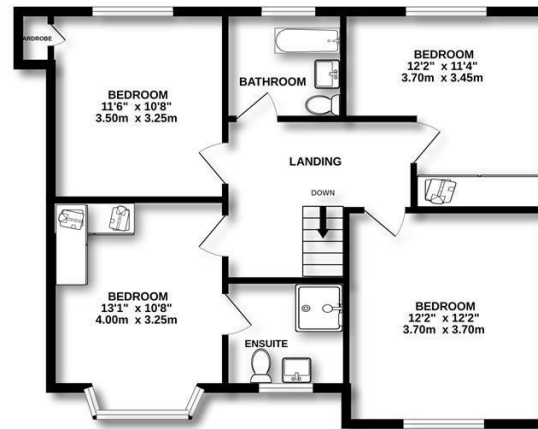

Patio area to the immediate rear with a meandering path leading to the raised decked area where you will find the garden room which is currently utilised as a bar but could easily be a home office with its own electric, light and power including Wi-Fi. The majority of the garden is laid to lawn with planted borders and fence / brick boundaries. Access to the side with pre-fabricated garage.
