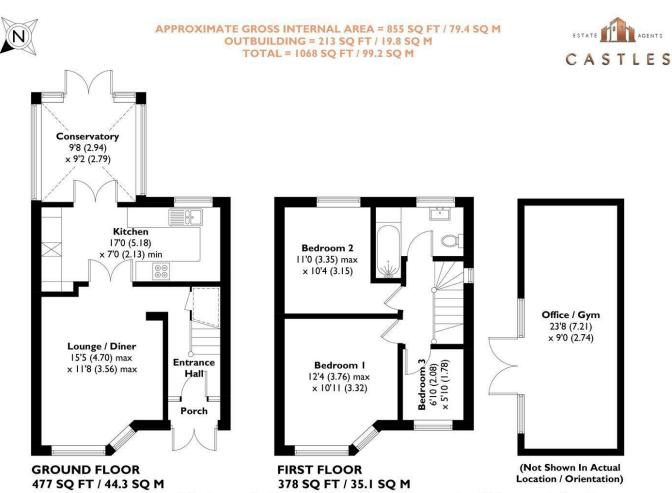
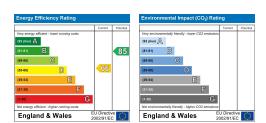
Floor Plan
